## HOW TO USE



1. The gel lathers with a very small amount of water.



2. Rub the sponge gently over the skin.



3. Rinse with water.



4. Discard the sponge.

## RECOMMENDATIONS FOR USE

- We recommend the use of protective gloves and sterile containers.
- Dry the skin with a drying cloth or towel.
- For bedridden patients or persons with reduced mobility, you can use a slightly damp cloth to remove the lather.
- To improve the patient's comfort you can moisten the sponge with warm water or heat the sponge (out of its package) in a microwave for a maximum of 30 sec. at 700W (Check temperature before use).
